The Nomination Committee with Mr Charlie Ong Chye Lee and Dato' Yoon Chon Leong abstaining from deliberation of their own assessments, had assessed the independence of Mr Charlie Ong Chye Lee and Dato' Yoon Chon Leong whave served on the Board as Independent Non-Executive Directors of the Company for a cumulative term of more than nine (9) years. Mr Charlie Ong Chye Lee and Dato' Yoon Chon Leong have met the independence guidelines as set out Chapter 1 of the Bursa Malaysia Securities Berhad Main Market Listing Requirements. The length of their service does not interfere with Mr Charlie Ong Chye Lee's and Dato' Yoon Chon Leong's abilities and exercise of independent judgeme as Independent Directors.

Meanwhile, as recommended by the Malaysian Code on Corporate Governance, the Board will be seeking shareholders' approval through a two-tier voting process at the Nineteenth Annual General Meeting to retain Mr Charlie Ong Chye Lee and Dato' Yoon Chon Leong as Independent Non-Executive Directors as their tenure has exceeded 9 years.
